- 1) fill in the application form according to the sample;
- 2) send abstracts in one of the working languages on the following e-mail: **kaf_boek_pdaa@ukr.net** (files should be named according to one of the topics of the conference and author's last name, for example: 3_Plaksienko_article, 3_Plaksienko_application);

Abstracts submission guidelines:

- In the top left corner – the name of the section according to the list above (font –Times New Roman, size 14). Below is the UDC code.
- Below, single-spaced, to the right – author’s first and last name, position, full name of the institution where the author studies or works (font – Times New Roman, size 14).
- Below, single-spaced, aline middle – the name of the report (capitalized): in bold type, font –Times New Roman, size 14.
- **Summary** (size 14, up to 30 words, width alignment).
- **Keywords** (size 14, up to 5 words, width alignment).
- Single-spaced – the text of the abstracts according to the following requirements: format A-4; spacing before the paragraph – 10 mm; margins – 20 mm; font –Times New Roman, size 14; line spacing 1.5;
- Pictures should be presented using the "Create Picture" function, font – Times New Roman, size 12, line spacing 1.0.
- The list of references should be submitted in accordance with the existing standard of bibliographic description (GOST 8302: 2015 “Information and documentation. Bibliographic reference. General requirements and rules of referencing”) after the text and contain no more than 5 items, each of which should be referenced in the text. In the text, references are given in square brackets with the number of the item from the reference list and the number of the page is separated by comma –for example: [5, p. 16].
- The size of the text: up to 3 full pages with references.

AUTHORS AND SCIENTISTS ARE RESPONSIBLE FOR THE CONTENT OF THE MATERIALS

Reports that do not meet these requirements will not be considered. The materials received from the participants of the conference are published in the author's edition.
